- Fuel must be in accordance with Schedule G of the Motorsport Australia Manual.
- · Vehicles must be adequately muffled.
- Rally/ offroad or aggressive tyres are not permitted at this Event.

Event is a Khanacross on unsealed (dirt) surface. It's a non-speed event which may use Stop/Go garages, witches' hats, cones, or similar to define the course.

#### **CLASSES AND CATEGORIES**

Class A: Production Cars: 0 to 1600cc
 Class C: Production Cars: 1601cc to 2000cc
 Class D: Production Cars: 2001cc to 3000cc
 Class E: Production Cars: 3001cc and over

Class G: 4-Wheel Drive Production Cars

- Class MP2: Highly Modified 2-Wheel Drive Production Cars, ie. Race/Rally cars or cars using Rally tyres or off-road, winter tread, bar-tread, mud-and-snow and hand-cut patterns.
- Class MP4: Highly Modified 4-Wheel Drive Production Cars, ie. Race/Rally Cars or cars using Rally tyres or off-road, winter tread bar-tread, mud-and-snow and hand-cut patterns and Group 4K Specials (including Group 4H Motorkhana Specials) and Superlite automobiles.

Category J: Juniors [refer notes 1, 2 & 4]
 Category L: Ladies [refer notes 2 & 4]

Category M: Masters [refer notes 2,4 & 6]

#### **NOTES**

- 1. Juniors are defined as having attained the age of 12 years and being under 18 years of age on the day of the first scheduled VKC round in the year of competition.
- 2. For Categories J, L and M, a handicap system will operate based on the class of the competing automobile. Handicap factors will be as in 3(b). A 0.93, C0.93, D 0.91, E 0.89, G 0.97, MP2 0.95, MP4 1.00.
- 3. Competitors are eligible to compete and to gain points in only one class at each round. The chosen class must be nominated on the entry form.
- 4. Eligible competitors may compete and gain points in a maximum of one category at each round. The chosen category must be nominated on the entry form. Note that a competitor who enters a category is also entered in a class and may gain awards and points in both.
- 5. A competitor may be reclassified or re-categorised for individual round awards (e.g. trophies) at the discretion of the Clerk of the Course if the competitor's nominated class/category has less than 3 entries. This will not change that competitor's class/category for annual awards points.
  - 6. Masters must have attained 65 years of age on the day of the first scheduled VKC round in the year of competition.

# JUDGE OF FACT

Judge of Fact shall be in respect to crossing a line, striking a marker, entering/exiting a garage, correctly following the Course, or any other similar requirement. These will be available and nominated on the day of the competition.

## **NOTES / OTHER REQUIREMENTS**

- The Organiser reserves the right to postpone or cancel the Event in accordance with the NCR.
- Protests must be lodged in accordance with the NCR.
- Results will be determined and distributed following the completion of the event, with awards presented at VKC R4.
- Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defuelling operation.

## **CATERING**

Catering at the venue will be supplied by Pakenham Auto Club, or BYO for all participants.

#### **AWARDS**

Awards will be presented at the End of Year Function.

# INTEGRITY
